ORDER FOR PROBATION WITHOUT JUDGMENT

This matter coming before the Court for the purpose of sentencing the defendant and a hearing having occurred pursuant to 730 ILCS 5/5-4-1 and the Court having considered the factors contained in subparagraphs (a)(1) through (a)(7) of said statute as well as 730 ILCS 5/5-6-3.1 FINDS THE DEFENDANT GUILTY of the offense(s) aaa and DEFERS entering judgment in this case.

IT IS THEREFORE HEREBY ORDERED BY THE COURT AS FOLLOWS:

Defendant is hereby placed on Probation for a period of _____ months, wider 720 ILCS 550/10 or 570/410. As conditions of Probation the defendant shall:

1. Not violate any criminal statute of any jurisdiction.
2. IMMEDIATELY report to the Jackson County Probation Department and continue to report to the Probation Officer of this Court, as such as the Probation Officer directs. The Probation Officer is authorized to perform visits at the defendant's home or place of employment.
3. Notify the Circuit Clerk and the Probation Office of any change of address or telephone number within 24 hours after such change occurs.
4. Refrain from possessing a firearm or other dangerous weapon.
5. Not leave the State without the consent of the Court, or in emergency situations, without prior approval of the Probation Officer.
6. Submit to random breath or urine analysis a minimum of three times during the period of probation.
7. Perform _____ hours of Public Service Work within the next _____ days with the approval of the Probation Office.
8. Pay the costs in this case.
9. Pay a fine in the amount of \$ _____ plus costs.
10. Pay a fine, costs and surcharges which total \$ _____.
11. Pay a Mandatory Assessment in the amount of \$ _____.
12. Pay a Street Value fine in the amount of \$ _____.
13. Pay restitution in the amount of \$ _____ through the Circuit Clerk's Office.

 - c. Undergo a mental health evaluation and successfully complete any recommended treatment.
