Instructions: If you have at least half the parenting time, you are required to give notice to the other parent if you plan to move with your child(ren):

- 1) From a home in Cook, DuPage, Kane, Lake, McHenry, or Will Counties to a new home in Illinois that is more than 25 miles away from your current home.
- 2) From a home in a county other than Cook, DuPage, Kane, Lake, McHenry, or Will to a new home within the state of Illinois more 50 miles away from your current home.
- 3) From a home anywhere in Illinois to a new home outside of Illinois that is more than 25 miles away from your current home.

You must give this notice to the other parent at least 60 days' before you plan to move unless special circumstances make that impossible.

If you plan to move but the distance is shorter than the distances listed above, you are still required to tell the parent your new address (unless the court has protected your address) but do not have to use this notice procedure.
