**APPLICATION FOR COURT SUPERVISION
WITHOUT COURT APPEARANCE**

READ CAREFULLY!!! Certain minor violations may be paid to the Circuit Clerk of Jackson County without going to Court.

SOME VIOLATIONS MAY NOT BE PAID WITHOUT A COURT APPEARANCE, NAMELY, ALL OFFENSES MARKED APPEARANCE REQUIRED and certain other violations determined by the Supreme Court of Illinois to be **MUST APPEAR** violations.

If you are charged with a violation that **DOES NOT** require a Court appearance, you may pay such minor violations by mail or in person at the Clerk's office.

WHAT IS COURT SUPERVISION?

Court Supervision is a method in which the Judge withholds entry of judgment (conviction) on your plea of guilty for a certain period of time, on the condition that the driver does not receive any additional tickets. A penalty is assessed and the case is continued for 90 days. If no future violations are received by the driver during the 90 days, the case is then dismissed. No report of conviction is sent to the Secretary of State to be added to your driver's record.

**YOU ARE ELIGIBLE FOR COURT SUPERVISION
WITHOUT A COURT APPEARANCE
IF YOU MEET THE FOLLOWING CRITERIA**

1. You have not been convicted of, or placed on Court Supervision for any moving violation within the prior 12 months;
2. You sign the Plea of Guilty and pay the prescribed fines and costs for the offense;
3. You understand that if you violate the law for another moving violation within the next 90 days for the date of the Order of the Court, that this Court Supervision may be terminated unsatisfactorily, and a conviction will be sent to the Secretary of State and entered on your driving record.

IF you meet the above criteria, and if your application for Court Supervision is accepted by the Judge, you will be granted Court Supervision for a 90 day period. You **DO NOT** have to come to Court, **UNLESS** you receive another notice from the Court stating you did not meet the criteria for Court Supervision, or that you received another ticket within the period of Court Supervision.

TO YOUR COURT DATE FOR PROCESSING**

I, _____, certify under penalty of perjury, pursuant to 735 ILCS 5/1-101, as follows: I have not been convicted of, or placed on Court Supervision, in any court for a moving traffic violation of any State Statute or Municipal Ordinance within the 12 months preceding this citation.

I further understand that my plea of guilty will be accepted and a conviction entered, if my driving record indicates that I have been convicted of, or granted Court Supervision, for a moving traffic offense within the 12 months preceding the issuance of the traffic ticket for which I am requesting Court Supervision.

I further understand that if I violate the law for another moving traffic violation within the next 90 days, that my Court Supervision may be terminated unsatisfactorily and a conviction entered against me and reported to Secretary of State
