

Published Standardized Court Forms

Per Supreme Court Rule 10-101, as of September 1, 2021, all courts must discontinue the use of any local forms that seek the same legal remedy as a standardized court form. (Local forms for which there is not a standardized court form replacement may continue to be used).

The following list outlines every currently standardized court form and can be used to cross-check whether local forms exist for the same legal remedy. This list will be updated as new forms are published, but the entire library of standardized court forms can be found at:
